# Operation Update #01

## Iran: Floods

This Operation Update is being issued for information only and reflects the current situation and details available at this time.

## A. SITUATION ANALYSIS

### Description of the disaster

As heavy rains continue to hit Iran since mid-March, floods remain a threat for many provinces, cities, villages, and infrastructure. Still more people are being evacuated and moved to safe areas and emergency shelters as the Iranian Red Crescent scale up its operations and resources to meet the imminent needs of the affected populations.

Extreme flooding and heavy rainfall which at times equaled more than half of the annual average within 24 hours; Golestan Province, for example, received 70% of its annual rainfall in just one day. This is unprecedented for the past 300 years.

Since 16 of March, almost all 31 provinces in Iran have been hit by flooding, damaging houses and infrastructure, affecting over 10,000,000 people. Most severely affected provinces are Gilan, Mazandaran, Golestan, Lorestan, Khuzestan and Khorasan Razavi., 78 people are reported dead, 1,136 injured and 2 million are in need.

Forecasted storms and rains over the coming days may scale up the floods impact and have the potential to disrupt the efforts of the humanitarian response. Southern and eastern parts of the country will be at greatest risk. Several cities and villages in Khuzestan Province have been already evacuated while 5 districts in Ahvaz City are under evacuation order.

The IRCS has been mandated by the Government to respond to the emergency needs of the affected populations in providing rescue and relief support. With IRCS teams and branches are responding in all affected areas since day one, the focus has been on the most five pretentious provinces starting with Mazandaran, Golestan, Ilam, Lorestan, and more recently Khuzestan. The latter province holds two major dams (Dez and Karkheh) that might at risk to break. People in areas at risk have been evacuated to safe areas and emergency shelters. At present, this risk is consider contained, as water outflow form the dams was increased.

## Summary of current response

### Overview of Host National Society

To date, a total of 94 Emergency Camps have been established and are managed by IRCS (67 Khuzestan, 15 Golestan, 4 Lorestan, and 8 Ilam). IRCS has mobilised a total of 28,000 volunteers and staff (including 4,200 operational teams), 17 relief and rescue helicopters, 24 mobile clinics, 41 boats, and more than 2,000 light and heavy relief vehicles. Utilizing these resources, IRCS undertakes a major operations through air, road and land, which reached 457,000 people through relief distributions and other services as follows:

#### Relief Services:

- 239,000 people are provided with emergency shelters
- 4,487 people transferred to safe areas
- 4,809 vehicles towed from water or snow
- 5,853 houses drained from water

#### Basic Health Care Services:

- 2,890 outpatient cases referrals
- 2,171 paramedical cases
- 629 mother and child cases
- 125 malnutrition cases (children under 5 years)
- 638 first aid psychosocial support
- 193 environmental health cases

IRCS has a memorandum of understanding with a number of partners RCRC NSs. The International Committee of the Red Cross (ICRC) has a delegation based in Tehran with various number of humanitarian activities in cooperation with the IRCS, and is on standby to support the IRCS operation (e.g. through RFL). Regular coordination meetings are held in country between Movement partners.

The German Red Cross, Turkish Red Crescent, and Kuwait Red Crescent have sent bilateral in-kind assistance to the flood-affected people, items are being distributed by the Iranian Red Crescent in Golestan and Khuzestan provinces. ICRC has allocated financial support to the NS.

A four-person FACT team has arrived in country. IFRC's Regional Director for MENA is in Iran to support local response efforts

Governmental authorities, NGOs and international actors in country are responding to the still developing emergency. The National Disaster Management Organization under the Ministry of Interior is coordinating relief efforts. Local communities are gathering to provide ad-hoc support as the need requires.

Governments of Swiss, Pakistan, Japan, Azerbaijan, Russia, Armenia, France, and Oman have provided in-kind donations, consigned to IRCS.
